

## Dear Guest(s),

We are pleased to inform you that we now offer Airline Check-In at Sea! Luggage Direct is an Airline luggage check-in program that will help expedite your departure to the airport after your cruise vacation, as you will not need to check-in at the airport. Your boarding passes will be issued onboard, and your luggage will be collected right from your stateroom the night before disembarkation and checked in all the way to your final destination airport! Sign up for the service onboard now, and you will not be required to pay any overweight airline baggage fees!



### **Benefits**

- Check-In for your flight onboard.
- Receive your boarding passes onboard.
- Luggage will be transported directly from your stateroom to the airport and onto your flight arriving at your final destination.
- Only \$25 fee for this service per person.
- Check-in at the airport not required.
- International and Domestic flights accepted. (If flying Delta Air Lines, only domestic flights accepted).
- No overweight baggage fees if you sign up onboard.
- Connecting flights do not have to be on a participating airline, as long as it is on the same reservation.



## Eligible Criteria

- You must disembark between 7:30am & 8:30am.
- Your flight departs after 11:30 am on the day of the arrival to Fort Lauderdale.
- You are flying from Fort Lauderdale.
   Service is currently not available for Miami International Airport flights.
- You have a confirmed reservation. No pending upgrades & standby reservations.
- You are flying with one of the below participating airlines.
- Some guests may be randomly selected by the airline to check-in at the airport and will not be able to use the service.



# Participating Airlines & Fees

When approved you will receive your luggage tags in addition to your boarding pass.

These will be sent to your stateroom on the day before your arrival into Port Everglades.

Depending on your departure time these might be delivered after 9:00pm.
